Note :- (5) The Register number of candidates who do not produce the required documents within the prescribed time limit and whose application found otherwise defective will be deleted from the Short List without further notice.

Note :- (6) Rechecking / Revaluation / photocopy of answer scripts of Dictation Cum Transcription Test is not allowed.

Note :- (7) Candidates included in the Short List who are eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P)No.81/09/SCSTDD dated 26.09.2009 or that obtained through e-district project in the format prescribed in G.O.(Rt)No.3942/2018/RD dated 24.09.2018 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O.(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of OTR Verification of original documents.
