<u>Note 5</u>: SC/ST candidates included in the Short List are required to produce two copies of Community Certificate issued by the Revenue Authority, not below the rank of Tahsildar for producing before the Public Service Commission.

The canidates belonging to Other Backward classes included in the Short List, who are required to produce Non Creamy Layer Certificate as per **G.O.(p)** No. 117/08/SC/ST/DD dated, 19.12.2008 or **G.O.(p)** No.81/09/SC/ST/DD dated, 26.09.2009 or **G.O.(p)** No.13232/F3/SC/ST/DD dated, 05.10.2009 shall produce the same along with the other documents mentioned above as and when called for. Such candidates in the Main List who failed to produce the required Community Certificate/Non Creamy Layer Certificate will not be entitled to the benefit of Community Reservation and will be considered as open competiotion candidates and such candidates who are included in the Supplementary Lists will not considered for the selection if they failed to produce NCLC/CC as the case may be.

The date, time and place of interview will be intimated in due course.

According to the existing procedure, revaluation of answer scripts is not allowed. But candidates can apply for re checking of their answer scripts after publication of the Ranked List for the post. Detailed instructions in this regard will be found in the Ranked List notification for the post.

Copy of the answer scripts of the OMR test held on 12.04.2012 will be issued to those candidates who apply for the same remitting the prescribed fee after publication of the Ranked List. The list of Physically Handicapped will be published later.
