**ORDER**

According to the provision in the Appendix 2B VIII (ii) of Kerala Public Works Account Code, every person appointed to the cadre of Divisional Accountant should pass the Divisional Accountants Test Examination.

2. The subjects of the examinations and minimum marks required for qualifying for a pass are as follows:-

Subject	Maximum marks	Minimum marks required for a pass
1 Public Works Accounts and Procedure (Written)— (i) Kerala Public Works Account Code (ii) Kerala Public Works Department Code (iii) Kerala Account Code, Vol.III	150	40 %
2 Accounts and Financial Rules (Written)— (i) Account Code (Central) Vol.I (ii) General Financial Rules (Central) Vols. I and II (iii) Compilation of the Treasury Rules (Central) Vols. I and II (iv) Kerala Financial Code, Vols. I and II (v) Kerala Account Code, Vols. I and II (vi) Kerala Treasury Code, Vols. I and II (vii) Kerala Service Rules	150	40 %
3 Viva-voce	150	40 %
Aggregate	450	45 %



3. Divisional Accountants have represented before Government to dispense with the 45% aggregate minimum marks required for a pass prescribed in the rule. In view of this, it was proposed to delete stipulation regarding percentage of marks in aggregate.

4. The matter was taken up with the Kerala Public Service Commission for its advice and it has agreed to the proposal.

5. After examining the matter in detail, Government are pleased to dispense with the 45% aggregate minimum marks required for a pass prescribed in the rules for the Divisional Accountants Test Examination under Appendix 2B para VIII (ii) of Kerala Public Works Account Code, with immediate effect.

6. Necessary amendments to the Kerala Public Works Account Code will be issued separately.
