(Fee rates: Answer script rechecking - Rs. 75/-, Photocopy of Answer script - Rs.300/-)

#### **Note 4:-**

Candidates belonging to Other Backward Classes included in this list who are required to produce Non-Creamy Layer Certificate as per GO(P) No. 81/09/SC/ST/DD dated 26/09/2009 shall produce the same along with the other documents mentioned above at the time of verification of original documents. SC/ST candidates included in the list are required to produce two copies of self attested Caste Certificate obtained from the Revenue Authorities not below the rank of Tahsildar issued to produce before Kerala Public Service Commission.
