For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section necessary Supplementary List is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (3) Candidates included in the Short List should be present in person and produce the original documents for One Time Registration Verification and Interview. Date, Time and Venue of OTR Verification and Interview will be intimated through profile message and SMS.

Note:- (4) SC/ST candidates included in the Short List are required to produce Community Certificate(in FormIII/Digitally Signed) issued by the competent Revenue Authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No 81/2009/SC/STDDdated 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS certificate in the format prescribed vide GO(MS) No 02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevent documents at the time of OTR Verification of original documents.

Note:- (5) For Online Examination, rechecking and revaluation are not allowed. But print out of Answer Sheets will be issued to those candidates who apply for it by remitting the prescribed fee after publication of the Ranked List. Detailed instruction will be incorporated in the Ranked List to be published for the Post.
