For the purpose of satisfying the rules of reservation of appointment to Scheduled castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any), necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes

Note :- (4) Candidates included in the Short List should present and produce in person the original documents to prove the Qualifications as mentioned in the Notification for the above mentioned post for One Time Verification. Date, time and Venue of OTR Verification will be published shortly.

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) The register number of those candidates who do not produce the required documents within the prescribed time limit and whose applications found otherwise defective will be deleted from the short List without further notice.

Note :- (7) Candidates included in the Short List ,eligible for reservation are required to produce Non Creamy Layer Certificate as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009/ Community Certificate issued by the Revenue authority / EWS Certificate as per G.O.(MS)No.02/2020/P&ARD dated 12/02/2020, Service Certificate in the prescribed format from concerned authority (for Govt. employees) shall produce the same along with the other documents at the time of verification of original documents.

Note :- (8) Copy of answer scripts of the OMR Test held on **15/09/2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. No answer scripts are invalidated **vide Notification No : ER VIII (2) 4755/2023/EW dated 29/12/2023**
