Note :- (3) **12(Twelve)** candidates who have secured top marks in the OMR Examination are included in the Main List of this Probability List. The Mark secured by the last candidate in the Main List is **81.67( Eighty One (point) Six Seven)** marks. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled tribes, other backward classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date, time and Venue of One Time Verification will be intimated in due course.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Probability List who are eligible for reservation are required to produce Non-Creamy Layer Certificate as per G.O(P)No.81/09/SCSTDD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue Authority and candidates who claim EWS reservation are required to produce EWS Certificate vide G.O(MS)No.2/2020/P&ARD dated 12.02.2020 issued by the Revenue Authority along with other documents at the time of One Time Verification of original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **12-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer the Notification No.ER II(2)4009/2023/EW dated 01/11/2023.
