The marks secured by the last candidate in the Main List is **78.75 (seventy eight (point) seven five)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes and Economically Weaker Section, necessary Supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) Candidates included in the Short List are required to produce NCLC as per G.O.(P) No. 81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates are required to produce Community Certificate issued by the Revenue authority and candidates who claim EWS reservation are required to produce EWS Certificate vide GO(Ms)No.2/20/P&ARD dated 12.02.2020 issued by the Revenue authority at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **26-03-2022** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ERIVB(3)4322/2022/GW dated 27.02.2024.
