Note:- (2) The list has been prepared by including the number of candidates who have secured top marks in the OMR Test.

Note :- (3) 11 candidates who have secured top most marks in the OMR Examination are included in the Main List of the Probability List. The marks secured by the last candidates in the Main List is **86 (Eighty six)** marks . For the purpose of satisfying the rules of reservation of appointment to Scheduled Caste, Scheduled Tribes Other Backward Classes (and other categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be intimated shortly.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate(in From III/Digitally Signed) issued by the competent Revenue authority, candidates belonging to Other Reservation Groups are required to produce Non Creamy Layer Certificate issued by the Village Officer as per G.O(P) No.81/2009/SC/ST/D Dated : 26.09.2009 and those belonging to Economically Weaker Section Category are required to produce EWS Certificate in the format prescribed vide GO(MS) No.02/2020/P&ARD dated 12/02/2020 in proof of their claim along with other relevant documents at the time of OTR Verification of Original documents.

Note :- (7) Copy of answer scripts of the OMR Test held on **09-08-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List. Candidates whose Register Numbers are invalidated are advised to refer to Notification No : ER IV B (1)3820/2023/EW dated 13/11/2023.
