NOTE (1) :- According to the existing procedure, revaluation of Answer Script is not allowed. Candidates who wish to obtain a printout of their Answer Sheets relating to this selection shall submit online Application through their One Time Registration profile from the official website of the Commission, www.keralapsc.gov.in by remitting the prescribed fee of Rs.335/- (Rupees Three Hundred and Thirtyfive Only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for printout of their answer sheet will be allowed to candidates with effect from the date on which the Ranked List is uploaded in the website of the Commission. Applications submitted in any other manner will not be considered. A copy of an answer sheet will be issued only once to a candidate.

NOTE (2) :- Any candidate can relinquish his/her right for appointment in writing in the format prescribed by the Commission duly attested by a Gazetted Officer of State/ Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the general conditions. "The Candidates who wish to relinquish their claim for advice from the Ranked list shall submit an Application in the format prescribed by the Commission. The format is available in the official website of the Commission. The request for relinquishment in respect of those who do not submit the Relinquishment Application in the format prescribed by the Commission will not be honoured under any Circumstances".The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission up to the finalization of the Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

NOTE (3) :- Since a common Online Examination with common candidates was conducted for this post, the marks awarded to the candidates included in this Ranked List and mark of all candidates appeared for the Online Exam will be published only after the publication of entire Ranked Lists (including NCA selections) which will be finalised on the basis of the common test.
