For the purpose of satisfying rules of reservation of appointments to Scheduled Castes, Scheduled tribes, Other Backward Classes and EWS necessary supplementary lists is prepared by including sufficient number of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note:- (4) Candidates included in the Probability List should present and produce in person the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note:- (5) According to the existing procedure, revaluation of answer scripts is not allowed but answer scripts can be rechecked after the publication of Ranked List. Detailed instructions will be published in the Ranked List to be published for the post.

Note :- (6) SC/ST Candidates included in the Probability List are required to produce Community Certificate issued by the concerned Revenue authority and Candidates belonging to other reservation group should produce Non Creamy Layer Certificate issued by Village Officer , EWS candidates should produce EWS certificate issued by Village Officer at the time of OTR Verification.

Note :- (7) Copy of answer scripts of the OMR Test held on **17-06-2023** will be issued to those candidates who, apply for the same remitting the prescribed fee after approval of the Ranked List.
