Note 1. Inclusion of register numbers in this list is purely provisional. This inclusion does not confer any right on the candidate for inclusion in the Ranked list to be prepared on the basis of the Main Examination.

Note 2. The register number of candidates who have secured top mark in the OMR Test (Common preliminary Exam Tenth Level) are included in the list.

Note 3. The candidates who have secured **82.49 (eighty two (point) four nine)** Marks and above after standardisation in the Preliminary OMR test are included in the eligibility list. The minimum marks for inclusion in the list of candidates belonging to various reservation communities have been lowered to ensure their adequate representation in the Eligibility list. Candidates whose inclusion is due to the benefit of reservation to ensure adequate representation, shall have to prove their claim by producing Community Certificate/Non Creamy Layer Certificate at the time of One Time Registration Verification. If they are included in the list to be published after the final examinations. If they fail to prove their claim, their application will be summarily rejected.

Note 4. The marks secured in the Common Preliminary Examination 10th level by the candidate will be considered only for ascertaining the eligibility to appear for the final exam and will not be considered for the purpose of final ranking and shall not have any relevance while preparing the Rank List for the post.

Note 5. If any of the documents produced by any candidate is found defective the Commission reserves the right for rejection of their candidature at any stage of selection as per rule.

Note 6. According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply through their One Time Registration Profile from the Commission's official website www.keralapsc.gov.in by remitting the prescribed fee of Rs. 85/- (Rupees Eighty Five Only) The fee can be remitted by e-payment through the portal. Applications submitted in any other manner will not be considered. A period of 15 (Fifteen) days time to apply for rechecking of answer scripts will be allowed to candidates with effect from the date on which the Eligibility List is uploaded in the Commission's website(on or before 25/4/2024) The candidate can avail only one chance after the approval of the Eligibility List. Rechecking of invalidated answer scripts due to any defects will not be considered. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded. Application submitted through e-mail/by post/in person will not be considered.

Note 7. Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall submit online application through their One Time Registration Profile from the Commission's official website www.keralapsc.gov.in by remitting prescribed Fee of Rs.335/- (Rupees Three Hundred and thirty five only) via e-payment mode available in the portal. A period of 15 (Fifteen) days time to apply for photocopy of OMR sheets will be allowed to candidates with effect from the date on which the Eligibility List is uploaded in the Commission's website(on or before 25/4/2024) A copy of an answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own and legal proceedings will be initiated against those who do so. Applications submitted through e-mail/by post/in person will not be considered.

Note 8. Candidates whose Register Numbers are invalidated are advise to refer to Notification No ER II (1)80/2024/EW dated 23/03/2024
