Note :- (2) The shortlist has been prepared by including the Register numbers of eligible and qualified candidates who have secured top marks in the Online Examination, based on the details furnished by the candidates in the application for the post. Subsequent claims made will not be entertained at any stage.

Note :- (3) 10 (Ten) candidates who have secured top most marks in the Online Examination are included in the Main List of the Short list. The marks secured by the last candidate in the Main List is **32.33 (thirty two (point) three three)**. For the purpose of satisfying the rules of reservation of appointment to Scheduled Castes, Scheduled Tribes, Other Backward Classes (and other reserved categories if any) necessary supplementary list is prepared by including sufficient numbers of candidates from lower mark ranges in the order of merit of the candidates belonging to such classes.

Note :- (4) Candidates included in the Short List should present in person and produce the original documents for One Time Verification. **Date,time and Venue of OTR Verification will be published shortly.**

Note :- (5) Candidates belonging to Other Backward Classes, included in this List, are required to produce Non Creamy Layer Certificate as per G.O(P) No.81/2009/ SCSTDD dated 26/09/2009 issued by Village officer and SC/ST candidates, included in the List, are required to produce Community Certificate (Form III or digitally signed) issued by the Revenue authority not below the rank of Tahsildar and candidates who claim EWS reservation are required to produce EWS certificate vide GO (M S) No 2/2020/P&ARD dated 12-02-2020 issued by the Revenue Authority, along with other documents at the time of OTR verification.

Note :- (6) For Online Examination, rechecking and revaluation are not allowed but printout of answer sheets will be issued to those candidates who apply for it by remitting the prescribed fee after the publication of Ranked List. Detailed instructions will be furnished in the Ranked List to be published for the post.
