- (iii) In case of change in caste/community noted in the SSLC Book, candidates must claim their original caste/community in the application and shall produce caste/community certificate or Non-Creamy Layer Certificate as the case may be issued by the Revenue Authorities and the original Gazette Notification publishing the change of caste/community at the time of OTR verification for selection to the above post.
