## NOTIFICATION

It is hereby notified that the following modifications are effected in the Ranked List for selection to the post of Higher Secondary School Teacher Computer Science/ Computer Application on Rs. 20,740 – 36,140/- in the Kerala Higher Secondary Education Department (Category No. 111/2010).

The inclusion of the name of the candidate Smt. Divyasree. S (Sl. No. 522) (included provisionally as Rank No. 73 in the Supplementary List for Ezhava/Thiyya/ Billava) is made absolute.
