The following is the list of candidates for selection to the post of **Male Warder in Jail Department (**NCA recruitment for Scheduled Caste, Muslim and Viswakarma) on Rs.5510-8590/- (PR) **in Thiruvananthapuram Unit** (This unit includes Thiruvananthapuram, Kollam, Pathanamthitta, Alappuzha Districts) found suitable by the Commission on the basis of the Objective Type (OMR) Test held on 07/07/2012 followed by the physical efficiency test conducted on 15.01.2014 and arranged in the order of merit for recruitment against the NCA vacancies for Scheduled Caste, Muslim and Viswakarma communities. The Ranked List is brought into force with effect from 24/02/2014 and will be valid until candidates are advised and appointed against the vacancies notified due to the paucity of candidates belonging to Scheduled Caste, Muslim and Viswakarma communities in the Ranked List published on 28.07.2010 for selection to the post.

According to the existing procedure, re-valuation of Answer Script is not allowed. But rechecking of marks will be done on payment of Rs. 50/-. The fee should be remitted in any one of the treasuries in the State under the head of account **"0051 PSC - 105 State PSC- 99 Examination Fee"** and original chalan enclosed with the application. Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the enquiry sections of the various offices of the Commission or its photocopy or downloaded and printed in A4 size paper from the Commission's website <u>www.keralapsc.gov.in</u> or photocopied therefrom. Applications submitted in any other manner will not be considered. The original challan receipt together with the application for re-checking should reach the **District Officer, K.P.S.C District Office, Pattom P.O, Thiruvananthapuram** within 45 days from the date on which this Ranked List is brought into force. The fee once remitted will not be refunded on any account.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.200/- by way of chalan in any of the treasuries in the State (Head of Account **0051 PSC-800 State PSC - 99 other receipts**). The duly filled up application in the prescribed form (available from the commission's website) along with the original chalan should be submitted to the **District Officer**, **K.P.S.C District Office**, **Pattom P.O**, **Thiruvananthapuram** within 45 days from the date on which the Ranked List is brought into force. A copy of the answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for copy of answer sheet which is not their own, and legal proceedings will be initiated against those who do so.

Valid applications for rechecking/ photocopy of answer script addressed to **District Officer**, **K.P.S.C District Office**, **Pattom P.O**, **Thiruvananthapuram** shall reach this office within 45 days from the date on which the Ranked List is brought into force. Application for rechecking/ photocopy received after the prescribed time limit and not in the prescribed form will not be enter-tained.
