NOTIFICATION

The following list contains the names of candidates found suitable on the basis of the result of the objective (OMR) type test held on **18.09.2010** for selection to the post of **Villageman** on Rs. **8730-13540** in the **Revenue Department** in Idukki District arranged in the order of merit. The ranked list is published on the basis of the Gazette Notification dated **31.12.2009 (Category No508/2009)** The Ranked List is brought into force w.e.f **14.05.2013**. The Ranked List will be in force for a minimum period of one year provided that the said list will continue to be in force till the publication of a new Ranked List after the expiry of a minimum period of one year or till the expiry of three years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

The candidates who have secured **63** (Sixty three) marks or above in the objective type test have been included in the Main List of the Ranked List. The requisite marks have been lowered to the extent necessary in respect of candidates under the reservation group of communities.

According to the existing procedure, re-valuation of Answer Script is not allowed. But re-checking of marks will be done on payment of Rs.50/- (Rupees Fifty only) in any one of the Treasuries in the State under the Head of Account "**0051 PSC,105 State PSC, 99 Examination Fee**". The fee once remitted will not be refunded on any account. The result of the rechecking will be intimated to the candidate from this office. Application for rechecking of answer script should be submitted in the prescribed form available free of cost from the Enquiry Section of the various officers of the Commission or its photocopy or downloaded and printed in A4 size paper from Commission's **Website www.keralapsc.gov.in** or photocopied therefrom. Applications submitted in any other manner will not be considered. The valid applications for rechecking of answer script along with the original chalan receipt for prescribed fee addressed to the District officer, Kerala Public service Commission, District Office, Idukki, shall reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the ranked list has been approved by the Commission). The last date

of receipt of applications for rechecking/ obtaining photocopy of the answer script is 27.06.2013. Applications for rechecking/ obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained. .

Candidates who wish to obtain the photocopy of the answer sheet have to remit a prescribed fee of Rs. 200/- (Rupees Two hundred only) which shall be remitted in any one of the treasuries in the State which is to be credited to the Head of account “ **0051-PSC-800 other receipts-99-other Receipts**”; and the Original chalan receipt should be attached with the application. The application form is given with this Notification. The copy of the OMR sheet will be given only once and copy for the both “A” Part and “B” part will be given. Copy of invalidated answer scripts will not be given. The photocopy will be sent by Registered post to the applicant. Candidate will be given the copy of their own answer script only and if it is proved, action will be initiated against the applicants. The application to obtain the photo copy of OMR answer script should reach this office within 45 days from the date on which the ranked list has come into force (i.e. the date on which the Ranked List has been approved by the Commission).

The entries put in column 8 (community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their application should intimate the fact to the District Officer, K.P.S.C District Office, Kattappana P.O, Idukki within 1 (one) month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in this list.

Note : Weightage marks for nativity will be granted subject to final orders in WA No.618/2012 pending before the Hon. High Court of Kerala.
