SC/ST candidates shall produce Caste Certificate obtained form Revenue Authorities not below the rank of Tahsildar as specified in Kerala Gazette and two self attested copies of the same along with other documents mentioned above. Such candidates in the Main List who fail to produce the required Non- Creamy Layer Certificate/ Caste Certificate will not be entitled to the benefit of community reservation and will be considered as Open Competition Candidates. The Register Numbers of the candidates in the Supplementary Lists who fail to produce the required Non Creamy Layer Certificate/ Caste Certificate will be deleted from the Probability List without further notice.

5. According to the existing procedure, revaluation of answer scripts is not allowed. But answer scripts will be re-checked and photocopy of answer scripts will be issued after the publication of Ranked List if applied as per rules. Detailed instructions in this regard will be found in the Ranked List notification for this post.

6. The Candidates must attend the certificate verification in person at one's own expense and absentees will not be included in the Ranked List.
