A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of answer sheet which is not their own and legal proceedings will be initiated against those who do so.

Valid applications for Rechecking/obtaining photocopy of answer script addressed to the District Officer, KPSC, District Office, Palakkad shall reach this office within 45 days from the date on which the Ranked List has come into force (ie. The date on which the Ranked List has been approved by the Commission) The last date for receipt of applications for rechecking/obtaining photocopy of the answer script is 11/11/2013. Applications for rechecking/obtaining photocopy, received after the prescribed time limit and not in the prescribed form will not be entertained.

Entries put in column 5 (Community) are based on the communities specified by the candidates in their application forms and proved by them with necessary documents. The candidates whose communities have not been correctly noted in the list as proved by them in their applications should intimate the fact to the District Officer, Kerala Public Service Commission, District Office Palakkad within one month from the date of publication of the Ranked List to get the benefit of reservation to which they are entitled to. In the absence of timely information regarding discrepancies, if any, the candidates will be advised as incorporated in the list.
