Note :- (6) Candidates belonging to Other Backward Classes included in this list who are required to produce Non – Creamy Layer Certificate as per G.O (P) No: 81/09/SC/ST/DD dated 26.09.2009 and SC/ST candidates included in this list are required to produce Community Certificate in Form III or digitally signed by the revenue authorities not below the rank of Tahsildar along with the other documents mentioned above at the time of verification of original documents.
