**5. Method of appointment** : **Direct Recruitment** ( From candidates belonging to the SCCC and Dheevara communities only)

**Note :-1.** Applications submitted by candidates belonging to communities other than the above communities will summarily be rejected. Individual communication regarding rejection of their application will not be issued.

2. Differently abled candidates with Hearing Impairment are not eligible to apply for this post.

**6. Age limit** : **19-44**. Only candidates born between 02.01.1975 and

01.01.2000 (both dates included) are eligible to apply for the post.(Including the relaxation as per para 2(i) of the

General Conditions)

**NOTE:** 19-46. For candidates belonging to SCCC Community, who have converted to Christianity from SC Community after attaining 18 years and the children of such parents born between 02.01.1973 and 01.01.2000( both dates included).

(For other conditions regarding age relaxation please See Para 2 of the General Conditions except 2(i))

## 7. Qualifications:

- 1 M.D(Ayurveda) Visha/Agadathantra awarded by a recognized University.
- 2 'A' class Registration in the Travancore- Cochin Medical Council.

Note: 1. Rule 10 (a) (ii) of Part II KS & SSR is applicable

- 2. Candidates who claim equivalent qualification instead of the qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 3. In the case of difference in original caste/community claimed in the application and that entered in SSLC book, the candidates shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of Certificate Verification.

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

b)If a written OMR/Online is conducted Test as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself.
