**6. Age limit : 18-36**

Only candidates born between 02.01.1978 and 01.01.1996 (both dates included) are eligible to apply for this post with usual age relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities. (For other conditions regarding the age relaxation please see para 2 of the General Conditions)

Note: Age relaxation will be allowed to officers of Technical Education Department to the extent of their service in the Department; subject to a maximum period of ten years over and above the relaxation in age, if any, allowed under general rules. In such cases, the maximum age shall not exceed fifty years.

**7. Qualifications :**

Diploma in Architecture Branch of Engineering/Technology awarded by a University/Government after undergoing regular course of study for not less than three years or its equivalent.

Note: Rule 10(a) (ii) of Part II KS&SSR is applicable.
