**Note:- (i)** Conventional type applications will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website.

(ii) Separate Ranked lists will be prepared for Eranakulam & Kollam district, in pursuance of this notification. The Ranked List thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in the ratio of 1:3 for by transfer/and Direct recruitment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidates is advised from the ranked list till the expiry of the period of three years the duration of the Ranked List shall be extended for a further period of one year or till at least one candidates is advised from the list whichever is earlier. In the absence of suitable candidates for appointment by transfer the vacancy shall be filled up by Direct recruitment.

- (iii) Applications should be submitted to the above districts in response to this notification. Candidates should note the name of the concerned Direct against the relevant column of the online application.

The candidate advised for appointment in the above Revenue District from the Ranked List prepared is not eligible for another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. - Note:- Proficiency in driving Light Duty Vehicles will have to be proved at a practical test including H. Test and Road Test. Those who pass H. Test are eligible for Road Test.

- (c) Muscles and Joints- No Paralysis and all joints must be capable of free movements.
- (d) Nervous Systems Perfectly normal and free from any infectious diseases.

#### Note:-

- (1) Physically Handicapped Candidates are not eligible to apply for the post.
- (2) Candidates should furnish the full details regarding the Driving License and experience in driving in the relevant column (qualifications) of the application form.
- (3) A practical test will be conducted for the selection to this post.
- (4) Candidates called for Practical Test will have to produce a Medical certificate in the prescribed form in original containing all relevant details as required in para 7 (iv) above (except iv (b) from a Medical Officer not below the rank of an Assistant Surgeon.
