**Method of appointment** : **Direct Recruitment (from among candidates belonging to Scheduled Castes and Muslim/Mappila Communities only).**

**2. Applications of candidates belonging to communities other than those mentioned above will be summarily rejected. Individual rejection memo will not be issued to them.**

**Age limit** : **Scheduled Caste: 18-47; Only candidates born between 02/01/1967 and 01/01/1996 (both dates included) are eligible to apply for the post.**  
**Muslim: 18-45; Only candidates born between 02/01/1969 and 01/01/1996 (both dates included) are eligible to apply for the post.**
