Exemptions for the post:

- (1) Those persons who have passed the state level eligibility test for the post of College Lecturers conducted by the Government of Kerala are exempted from passing State Eligibility Test for Higher Secondary School Teachers.
- (2) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing State Eligibility Test.
- (3) Persons with Ph.D/M.Phil/M.Ed Degree shall be exempted from passing the State Eligibility Test provided the M.Phil in the concerned subject should be one awarded by any of the universities of Kerala or recognized as equivalent thereto by any of the universities of Kerala.
- (4) The teachers who have completed Ten(10) years of approved teaching service at the High School Level in the General Education subordinate service shall be exempted from passing the State Eligibility Test for Higher Secondary School Teacher.

Note:- Higher Secondary School Teacher (Junior) means part time post of Higher Secondary School Teacher.

7 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registeration Card. Candidates are responsible for the correctness of the personal information and secrecy of password.
