1. Department : Collegiate Education

2. Name of Post : Lecturer in History

3. Scale of pay : U G C Scale

4. Number of vacancies : Dheevara – 1 (One)

Note:- The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked to the above reservation group but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 31.07.2009 for the post. This is the second NCA notification for the post owing to non availability of qualified candidates even after the first NCA Notification published in the Gazette Date 31.05.2013 as Category No. 140/2013.

**5. Method of appointment** : **Direct Recruitment.** [Only from candidates belonging to the reservation group viz. Dheevara]

**NOTE:** Applications of candidates belonging to community other than the above will be summarily rejected. Individual rejection memo will not be sent to them.

**6. Age** : **22 – 43**. Only candidates born between 02.01.1971 and

01.01.1992 (both dates included) are eligible to apply. [For other conditions regarding age relaxations please see para 2 of general conditions given in the Gazette

Notification [except para 2(i)(ii)(iii) and (iv)].

## 7 Qualifications

- 1. Masters Degree in the concerned subject with at least 55% marks or its equivalent with good academic record .
- 2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.
  - Note: (i) Rule 10 (a) (ii) of Part II KS & SSR is applicable.
    - (ii) For PhD holders who have passed Masters Degree prior to 19.09.1991, 50% marks for Masters Degree shall be sufficient.

- (iii) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination. (G.O.(MS)No.86/07/H.Edn dated 19.06.2007)
- (iv) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.

### 8. Mode of submitting Applications:-

Before applying for the post, candidates should register as per "ONE TIME REGISTRATION" through the Official website of Kerala Public Service Commission <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>.
