# 7. Qualifications

- 1. Masters Degree in the concerned subject with not less than 55% marks or its equivalent and good academic record .
- 2. Must have passed a Comprehensive Test in the concerned subject specifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess adequate knowledge in Malayalam.

    - (ii) Candidates who have obtained Ph.D Degree in the concerned subject are exempted from passing the NET examination.

- (iii) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.
