Note: Persons who have (as per GO(MS)357/76/Health dated, 27.09.1976) undergone successful Training in the Artificial Limb Centre attached to the Medical College, Thiruvananthapuram under Half a Million Job Programme will be eligible for relaxation of five years in the upper age limit.
