6. **Age** : <u>OX Candidates</u>

18-48. (Only candidates born between 02/01/1966and 01/01/1996 (both dates included) are eligible to apply for this post. The upper age limit mentioned above shall be raised up to 50 (Fifty) years of age in the case of candidates belonging to adult member, of Scheduled Caste and their children when such adult members are converted to Christianity (including relaxation in Para 2(i) of General Conditions.

Scheduled Caste/Scheduled Tribe Candidates

18-50. (Only candidates born between 02/01/1964 and 01/01/1996 (both dates included) are eligible to apply for this post. (including the relaxation as per para 2(i) of the General conditions)

Note:- 1. The provisional hands working in the above concern will be given age relaxation to the extent of their provisional service put in subject to a maximum of five years from the upper age limit provided they are within the prescribed age limit on the date of their first appointment in the above concern. But the regular employees of the concern are not eligible for the above concession for further appointment.
