- (iii) Separate Ranked List will be prepared for above District in pursuance of this notification. Ranked List thus prepared and published by the Commission shall remain in force until candidates are advised and appointed against the vacancies earmarked for the above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published for the post on 12.02.2013 in Thiruvananthapuram district as Category No. 255/08.

(iv) The candidates should submit application for the post to the concerned district where the vacancy is existing for their respective community and shall note the name of that district against the relevant column in the online application. Applications should not be sent to more than one district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected, his/her name will be removed from the ranked list and disciplinary action will be taken against him/her.

(v) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O. (MS) No. 154/71/PD dated, 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (MS) No. 4/61/PD, dated 2.1.1961.
