Note :- (i) Conventional type application will be summarily rejected. Candidates shall apply only through online application available at the Kerala Public Service Commission website.

- (ii) Separate Ranked list will be prepared for Idukki district in pursuance of this notification. The Ranked Lists thus prepared and published by the Commission, shall remain in force for a minimum period of one year, subject to the condition that the said lists will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment in the ratio of 1:3 for by transfer/promotion and Direct recruitment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the lists. In case no candidates is advised from the ranked list till the expiry of the period of three years the duration of the Ranked List shall be extended for a further period of one year or till at least one candidates is advised from the list whichever is earlier. In the absence of suitable candidates for appointment by promotion/transfer the vacancy shall be filled up by Direct recruitment.
- (iii) Applications should be submitted to Idukki district in response to this notification. If applications are submitted contrary to the above direction and if he/she is selected his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should note the name of the concerned District against the relevant column of the online application.

Note: Candidates should submit separate application for Direct recruitment and Recruitment by transfer.

(iv) The selection in pursuance of the notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one

Revenue district from the ranked list prepared is not eligible for transfer to another district unless he/she completes 5 years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after 5 years, it will be subjet to the rules in G.O.(MS)No. 4/61/PD dated, 02.01.1961.

Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.

6. Age limit : 18-39

- 3.Proficiency in Driving-Medium/Heavy goods/ passenger motor vehicles which is to be proved in a practical test conducted by KPSC during the course of selection.

Note:- Proficiency in driving Heavy Duty Vehicles will have to be proved in a practical test including H.Test and Road Test. Those who pass H.Test are eligible for Road Test.

- 1 Physically Handicapped candidates are not eligible to apply for the post.
- 2 Candidates should furnish the full details regarding the Driving Licence and experience in driving in the relevant column (qualifications) of the application form.

- 3 A practical test will be conducted for the selection to this post.
- 4 Candidates called for practical Test will have to produce a Medical Certificate in the prescribed form in original containing all relevant details as required in para 7(iii) (except iii(b) above from a Medical Officer not below the rank of an Assistant Surgeon.
 - A Medical certificated regarding eye sight from a Ophthalmologist in Government Service also will have to be produced.
