This is the Sixth NCA Notification for the post owing to the non availability of qualified candidates belonging to the above community as per the first NCA Notification (Gazette date: 31.12.2010, Cat. No. 494/2010), Second NCA Notification (Gazette date: 16.07.2012, Cat. No. 387/2012), Third NCA Notification (Gazette date: 31.12.2014, Cat. No. 714/2014), Fourth NCA Notification (Gazette date: 14.06.2016, Cat. No. 126/2016) and Fifth NCA Notification (Gazette date: 28.06.17, Cat. No. 231/2017).

5. Method of appoin:

Direct Recruitment (Only from candidates belo nging to Scheduled Castes). But the application s of Scheduled Tribe candidates will be conside red in the absence of Scheduled caste candidat es.

NOTE: Applications of candidates belonging to communities other than Scheduled Castes/Scheduled Tribe mentioned in this notification will be summarily rejected. Individual rejection memo will not be sent to them.

6. Age: 22-45. Only candidates born between 02.01.1974 and 01.01. 1997 (both dates included) are eligible to apply. [For other c onditions regarding age relaxations, please see Para 2 of the General Conditions of the Gazette notifications, excluding pa

## 7. Qualifications

- 1. Masters Degree in the concerned Subject with at least 50% marks or it s equivalent and good academic record.
- 2. Must have passed a Comprehensive Test in the concerned subject spec ifically conducted for the purpose by UGC or any agency duly constituted by the state government in this behalf. When qualifications are being equal, preference shall be given to those candidates who possess ade quate knowledge in Malayalam.

Note: (i) Candidates who have obtained Ph.D Degree in the concern ed subject are exempted from passing the NET examination

- (ii) For recruitment to various posts under these rules, Degrees awarded by the Universities recognized by UGC alone shall be considered.
- (iii) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (iv) In case of change in caste noted in the SSLC book, candida tes must claim their original caste in the application and mus t produce Caste Certificate/Non-creamy layer Certificate o btained from the revenue authorities and the relevant Gazett e notification to prove the caste at the time of verification.
- (v) KS & SSR Part II Rule 10(a)(ii) is applicable.

8.a) Mode of submitting Applications:-

Candidates must register as per 'ONE TIME REGISTRATION' with the offi cial Website of Kerala Public Service Commission ie, www.keralapsc.gov.in b efore applying for the post. Candidates who have registered can apply by logg ing on to their profile using their User-ID and password. Candidates must clic k on the 'Apply Now' button of the respective post in the Notification Link to apply for the post. The Photograph uploaded should be taken after 31/12/201 0. Name of the candidate and the date of photograph taken should be printed legibly at the bottom portion of photograph. The photograph once uploaded m eeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photograph s. No application fee is required. Candidates shall take a printout of the applic ation by clicking the link 'Registration Card' in their profile. Candidates are res ponsible for the correctness of the personal information and secrecy of passw ord. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote t he User-ID for further communication with the Commission. Application sub mitted is provisional and cannot be deleted or altered after submission. The ap plication will be summarily rejected if noncompliance with the notification is f ound in due course of processing. Documents to prove qualification, age, com munity etc have to be produced as and when called for.
