Note:- i) Rule 10 (a) (ii) of Part II of KS & SSR is applicable.

- **ii)** Candidates who are appointed in the post should serve for 4 (Four) years during the first 10 years of their service (including the period of training) anywhere in India or any other foreign country under defence services connected with defence, if required. Differently abled candidates and those who have completed 45 years of age are exempted from the above compulsory Military Service.
- **iii)** Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- **iv)** In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

Name of the candidate and the date of taking photograph should be printed at the bottom portion in white background. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove

qualification, experience, community, age etc. have to be produced as and when called for.

- **(b)** If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
