**NOTIFICATION**

Applications are invited online only by **One Time Registration** system exclusively from qualified candidates for selection to the under mentioned post in Kerala Government Service. Applications must be submitted online through the official website of the Kerala Public Service Commission after One Time Registration. Candidates who have already registered shall apply through their profile.

1. **Department** : Sainik Welfare
2. **Name of Post** : **Welfare Organiser**
3. **Scale of pay** : Rs.26,500 - 56700/-
4. **No. of vacancies** : **District wise**  
Ernakulam - 01 (One)

**Notes:**

- (i) *The ranked list prepared and published by the commission in pursuance of this notification shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of new list after the expiry of the minimum period of one year or till the expiry of three years whichever is earlier. Candidates will be advised for appointment against the aforesaid vacancies and also against the vacancies, if any, reported during the currency of the list.*
- (ii) *The selection in pursuance of the notification will be made on a revenue district basis subject to the special conditions laid down in GO (MS) No.154/71/PD dated 27/05/1971. A candidate advised for appointment from the Ranked List prepared in one revenue district is not eligible for transfer to another district unless he/she*

*completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G.O. (P) No. 36/91/P&ARD, dated 02.12.1991 for inter district transfers. Candidates already in Government service holding this post in any district are prohibited from applying in response to this notification.*

*(iii) If the community claim in the application differs from the community noted in SSLC, then such changes are to be published in the gazette on or before the date of verification of original documents and the same should be produced along with the Community Certificate/Non Creamy Layer certificate issued by the Revenue authorities at the time of One Time Verification or as and when required by the Commission.*

5. **Method of appointment** : Direct Recruitment (Ex-servicemen only)
6. **Age** : Should not have completed 50 (Fifty) years of age (including relaxation for Military service) as on 01.01.2019.

**Notes:-**

- (i) Relaxation in upper age limit will not be allowed to this post.*
- (ii) Attested true copies of the military Discharge certificates should be produced as and when called by the Commission.*
- (iii) Candidates who are selected for appointment as per this notification should not have completed 56 years of age while joining duty.*

7. **Qualifications :-**

- a) Pass in SSLC or its equivalent.
- b) Candidates should be Ex -Junior Commissioned Officer in the Army or Ex-Servicemen of equivalent rank in Navy or Air Force.

*Note: i)Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as required by the Commission.*

*ii) KS&SSR Part II Rule 10(a) (ii) is applicable for selection to the post.*

8. **Mode of submitting applications:-**

Candidates must register as per ONE TIME REGISTRATION with the Official Website of Kerala Public Service Commission [www.keralapsc.gov.in](http://www.keralapsc.gov.in) before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID

and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, experience, Community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.**

10. **Last date of receipt of applications 29/08/2019** Thursday upto 12 midnight.
11. If Written Test/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
