7. Qualifications : 1. Must possess MBBS Degree from a recognised University

with one year House surgency.

2. Registration under part A of the Kerala Medical Council.

Preferential: Post Graduate Diploma in Industrial Health.

Note:- (i) Rule 10 a (ii) of Part II KS & SSR is applicable.

- (ii) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (iii) If there is difference in original caste / community claimed in the application and that entered in the SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate / Community certificate at the time of certificate verification.

No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for. The profile correction made by candidate or in the office of KPSC on request after the last date fixed for the receipt of application will not reflect in the application. Such corrections will be in effect on the date on which correction have made.
