7 **Qualifications** Degree in Pharmacy of a recognized University.

Note:-

- 1. Direct Recruitees shall be on training for six months from the date of joining in service. Probation shall commence after successful completion of training.
- 2. Rule 10(a)ii of Part II KS & SSR is applicable.
- 3. Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

4. In the case of difference in original Caste/Community claimed in the application and that entered on SSLC book, the candidates shall produce Gazette notification in this regard, along with Non Creamy Layer Certificate/Community Certificate at the time of certificate verification.

The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, age, Community etc. have to be produced as and when called for.
- **(b)** If written /OMR/Online is conducted Test as part of this selection candidates shall submit a confirmation for writing the examination through their One Time Registration Profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely.
