  - (ii) Separate Ranked Lists will be prepared for the above districts in pursuance of this notification for the above communities. Ranked List thus prepared and published by the Commission shall remain in force for three years or until candidates are advised and appointed against the vacancies earmarked for the above communities unfilled due to paucity of candidates during the currency of the Ranked List, whichever is earlier.

- (iii) The selection in pursuance of this notification will be made on a Revenue District basis, subject to the special conditions laid down in G.O (MS) No. 154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List prepared is not eligible for transfer to another district unless he/she completes five years continuous service from the date of commencement of service in the former district. Even if transfer is allowed after five years, it will be subject to the rules in G O (P) No. 36/91/P&ARD, dated 02.12.1991. But as per G.O (P) No. 12/96/P&ARD dated 16.03.1996, the condition of 5 years service is not applicable for the transfer to the Districts of Idukki, Wayanad and Kasaragod. This concession will be available only for getting transfer into these districts, but not for getting transfer out of these districts and this concession will be granted only once in the career of Government Servant. Candidates already in Government Service holding this post in any one district are prohibited from applying again for this post, but they can apply to higher posts when notified.
- (iv) Applications should not be submitted to more than one district in response to this notification. If applications are submitted contrary to the above direction, and if he/she is selected, his/her name will be removed from the Ranked List and disciplinary action will be taken against him/her. Candidates should submit the application for this post to the concerned district office and should note the name of the concerned District against the relevant column of the online application.
- (v) If the community claim in the application differs from the community noted in SSLC, then such changes are to be published in the gazette on or before the date of verification of original documents and the same should be produced along with the Community Certificate/Non Creamy Layer certificate issued by the Revenue authorities at the time of One Time Verification or as and when required by the Commission.

- 5. **Method of appointment** :- Direct Recruitment (From candidates belonging to Muslim, Viswakarma, Dheevara, OBC, LC/AI & Scheduled Caste communities only)
- Age Limit :- 18-39 (for Muslim, Viswakarma, Dheevara, OBC & LC/AI communities). Candidates born between 02.01.1980 and 01.01.2001 (both dates included) are eligible to apply for this post. (Including the relaxation as per Para 2(i) of the General condition)

18-41 (for SC community only). Candidates born between 02.01.1978 and 01.01.2001 (both dates included) are eligible to apply for this post. (Including the relaxation as per Para 2(i) of the General condition)

[For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 (fifty) years. Please see Para (2) of the General conditions under Part II of this notification] except para 2(I).

### 7. Qualifications:-

(i) A Pass in 10<sup>th</sup> Standard or its equivalent.

(ii) K.G.C.E in food Production from Government Food Craft Institute or any other equivalent qualification recognized by Government of Kerala.

**Probation**: Every persons appointed to the category shall be on probation for a total period of one year on duty within a continuous period of three years.

#### <u>Note</u> :-

(a) Those who claim equivalent qualification shall produce the respective Government Order to prove the claim at the time of One Time Verification or as required by the Commission.

(b) KS&SSR Part II Rule 10(a) (ii) is applicable for selection to the post.

### 8. Mode of submitting Applications :-

Candidates must register as per ONE TIME REGISTRATION scheme through the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the Apply Now button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of taking of the photograph. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile, candidates must ensure the correctness of the information on their profile. They must quote their User-ID for further communication with the Application submitted is provisional and cannot be deleted or altered after Commission. submission. The Application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove Qualification, Experience, Community, age etc. have to be produced as and when called for. Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.

The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phones registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
