- (ii) In the case of change in Caste/Community noted in the SSLC Book, candidates must claim their original Caste/Community in the application and shall produce Non-Creamy Layer Certificate issued by the Revenue Authoritites and the Original Gazette notification publishing the change of Caste/Community at the time of OTR verification for the selection to the above post.
- (iii) The selection in pursuance of this notification will be made on a revenue district basis, subject to the special conditions laid down in G.O.(MS) No. 154/71/PD dated 27/5/1971.
