- 5. Method of appointment : Direct Recruitment from candidates belonging SC community in the State of Kerala who acquired Physiotherapy Assistant Class-II training given to the Armed Forces.
  6. Age limit: 18-41. Only candidates born between 02.01.1978 and 01.01.2001 (both dates are included) (including para 2(i) of the General conditions) are eligible to apply for this post. (For other conditions regarding the age relaxation, please see Para 2 of the General Conditions except para 2(i))
- 7. Qualifications: A pass in the Pre University or equivalent qualification with the training given to Physiotherapy Assistant Class-II, Armed Forces.

Note:

(i) The training will be one obtained for the full training period of Physiotherapy in the Armed Forces.

(ii) Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

(iii) In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

# 8. Mode of submitting Application :

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission <u>www.keralapsc.gov.in</u> before applying for the post. Candidates who have registered can apply by log in on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to applying for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required.

Candidates shall take a printout of the application by clicking the link Registration card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.

(b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.
