Applications are invited online only exclusively from qualified candidates belonging to Scheduled Caste Converts to Christianity (SCCC) communities of Kerala State for NCA selection to the following Post. Applications shall be submitted through the official website of Commission (www.keralapsc.gov.in) after ONE TIME REGISTRATION. Candidates who have registered can apply through their profile. Candidates who have <u>AADHAR card should add AADHAR as ID proof in</u> their Profile.

1. Department : Fire and Rescue Services

2. Name of post : Fireman (Trainee)

3. Scale of Pay : Rs. 20,000 – 45,800

4. Number of Vacancies : Scheduled Caste Converts to Christianity

(SCCC) - 01 (One)

Note i:- Applications submitted by candidates belonging to the communities other than Scheduled Caste converts to Christianity (SCCC) communities will be summarily rejected. No rejection memo will be issued to such candidates.

Note ii:- The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancy earmarked for above community, but remain unfilled due to paucity of candidates during the currency of the Ranked List published on 17.12.2018. (Cat No.069/2017).

Note iii:- In the case of difference in original caste/community claimed in the applications and that entered in SSLC book, the candidate shall produce a gazette notification in this regard along with Non-creamy layer certificate/caste certificate issued by competent revenue authority, at the time of verification.

5. Method of appointment: Direct recruitment (from candidates belonging to Scheduled Caste Converts to Christianity (SCCC) only.

Note: Differently Abled and female candidates are not eligible to apply for this post

6. Age Limit: 18 –29.

Only candidates born between 02.01.1990 and 01.01.2001 (both dates included) are eligible to apply for this post. In the case of adult members of SC and

their children converted to Christian religion the upper age limit shall be 31 years ie. candidates born between 02.01.1988 & 01.01.2001 (Including age relaxation as per para 2(1) of the general conditions).

Note: Other conditions regarding age relaxation in para 2 of Part II general conditions of the Gazette Notification are not applicable to this selection.

7. Qualifications:

1. **Educational Qualifications:**

Pass in Plus Two or its equivalent.

Note: (KS & SSR Rule 10(a)(ii) Part II applicable)

Diploma in Computer Application is Preferential.

2. **Physical Qualifications**

The Candidates must be physically fit and should possess the following minimum physical standards as prescribed below

Note: Physical Measurement of the candidates will be taken prior to the test and those who do not satisfy the prescribed Physical standards will not be allowed to participate in the Physical Efficiency test under any circumstances.

3. Must have proficiency in swimming

Note:- The proficiency in swimming will be tested by a practical test conducted by the commission. The following are the criteria for the swimming test.

- (i) 50m swimming trial to be completed within two minutes.
- (ii) Two minute floating ability at the deeper sides of the swimming pool. Candidate must qualify both the events to be considered as qualified in the swimming test.

4. <u>Visual Standards</u> Must possess the Visual Standards specified below without glasses.

Candidates should produce a Medical Certificate issued by a Medical Officer not below the rank of a Civil Surgeon as to the candidates physique, fitness and capacity for rough outdoor work and also of the visual standards when the commission intimates.

Note: Details regarding standards of vision should be clearly stated in the Certificate, as given above. Vague statements such as vision normal/Average etc. will not be accepted. Specification for each eye should be stated separately. If the specifications are not as indicated above, the certificate will not be accepted.

5. Physical Efficiency Test – A Physical Efficiency test will be conducted by the commission to assess the physical efficiency of the candidates. Candidates must qualify in at least 5 out of 8 items in the physical efficiency test showing the minimum standards of efficiency as noted below.

- **8. Preferential:** Other conditions being equal, the Home Guard Volunteers who have completed a tenure of three years in that organizations and who have satisfactorily undergone training in Fire Fighting during the period of tenure shall be treated as having preferential qualification for direct recruitment to this post.
- **9. Probation:**-Every Person appointed to the post shall from the date on which he joins duty after he completes the training and examination will be on probation for a period of two years on duty within a continuous period of three years.

10. Training:-

- (i) Training for a period of 6 months in the State Fire Service Training School or in any other institution as may be fixed, and pass the examination in the subject prescribed for the course.
- (ii) After the above training Six months practical training at a Fire station and a pass in the examination in the subjects prescribed for the course.

Note:

- (i)A Written and practical test will be conducted during the last fortnight of the period of training at the close of training. Those who fail to qualify in either on or both tests shall have their training extended for a further period of one month, at the end of which they shall be tested again in the subjects in which they failed. The Director of Fire & Rescue Services shall allow a third chance to pass the course to all fireman recruits who fail at the re-test.
- (ii) Seniority among Recruits, who have qualified in the test conducted by Fire and Rescue Services Academy shall be determined on the basis of effective advice of KPSC and they shall be appointed to service on the basis of seniority list, only after completion of successful training.
- **Bond:** A Person appointed by direct recruitment to the post of Fireman shall execute a bond, binding himself to service in the department for a period of 7 years and to pay to Government an amount of Rs 50,000 in case of failure to serve in the department for the said period.

12. Mode of submitting Applications:

Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' before applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification link to apply for a post. The photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading of the photograph. There is no change in other instructions regarding the uploading of photograph. No application fee is required. Candidates can view the details in their profile by clicking the link Registration Card in their profile. A printout of the same can be taken if needed. Candidates are responsible for the correctness of the personal information and secrecy of password. Before final submission of the application on the profile, candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the commission. Applications once submitted is provisional and cannot be deleted or altered after submission. Applications will be summarily rejected if non compliance with the notification is found in due course of processing. Documents to prove Qualification, experience, community, age etc. have to be produced as and when called for.

The applications of candidate who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of admission tickets will be published in the examination calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
