Note (i): The above Vacancies are now in existence. Separate Ranked List will be prepared for each district in pursuance of this notification. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancies and also for the vacancies reported for Special Recruitment from Scheduled castes / Scheduled Tribes during the currency of the list. Candidates against vacancies reportedexclusively for Scheduled Tribes will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list fresh notification for vacancies reserved exclusively for Scheduled Tribes will be issued.

- Note:(ii) The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special conditions laid down in G.O (MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she complete five (5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the orders contained in G.O(Ms)No.4/61/PD dated 2.1.1961. Candidates already in Government service, holding the post in any one District are restricted from applying for the same post in another District. But they can apply for higher posts when notified.
- **Note:(iii)** Candidates from the Ranked List for district wise selection will be advised for appointment against the Headquarters vacancies also. As per the provision in G.O(Ms) 154/71/PD dated 27.05.1971 appointments against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.
- **Note:(iv)** Applications should not be submitted to more than one district in response to this notification. If applications are sent contrary to the above direction and if he/she is selected, his /her name will be removed from the Ranked Lists and disciplinary action will be taken against him/her. Candidates should submit the application for this post to the district office concerned, where the vacancy is existing and should note the name of that district against the relevant column of the online application.
- **5. Method of Appointment :** Direct Recruitment (Special Recruitment from among Scheduled caste & Scheduled Tribes only).

Note:-Applications received from candidates other than Scheduled Caste & Scheduled Tribe will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age : 18-46

Only Candidates born between 02.01.1973 and 01.01.2001 (both dates included) are eligible to apply for this post.(No other age relaxation will be allowed)

Note : In the absence of qualified candidates within the age limit the upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 **Qualifications:**

- **1)** <u>**General**</u>: Pass in SSLC or its equivalent qualification specified in the General rules
- **2)** <u>**Technical**</u> : Auxiliary Nurse Midwifery certificate (Revised Course of 18months duration), issued by Kerala Nurses and Midwives Council

Auxiliary Nurse Midwifery certificate/Auxiliary Nurse Midwifery certificate (Revised Course) issued by an Authority recognized by the Indian Nursing Council.

OR

Health Workers training Certificate issued by the Kerala Nurses and Midwives Council.

3) Registration with Kerala Nurses and Midwives council.

Note: 1. Rule 10(a)(ii) of part II of KS&SSR is applicable

- 2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 3. If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.
- 4. In the case of candidates belonging to Scheduled Tribes, General Educational Qualification will be pass in Standard VIII. The relaxation will be allowed only in the absence of fully qualified Scheduled Tribe candidates and to the extend necessary for filling up the quota reserved for Scheduled Tribe candidates alone.
- 5. In respect of Scheduled caste the General Educational Qualification will be relaxed as completed S.S.LC Course.(failed candidates are also eligible). The above relaxation will be allowed only extend necessary to fill up the quota reserved for Scheduled Caste candidates.
- 6. Physically Handicapped candidates are not eligible to apply for this post.
- 7. Candidates who have claimed bogus information about qualification and Experience in application and will or will'nt attend the exam after giving confirmation, disciplinary action will be taken against him/her as per the Rules of procedure of Rule 22.

8 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for

further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. "Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile".
