- **5 Method of Appointment** : Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes only).
- <u>Note:-</u> Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.
- 6 Age 18-41 : Only Candidates born between 02.01.1979 and 01.01.2002 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.
- **Note:-** In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

- 1. Pass in SSLC or its equivalent qualification.
- 2. Type writing English Higher KGTE and Word Processing or equivalent qualification.
- 3. Type writing Malayalam Lower KGTE/MGTE or equivalent qualification

Note: 1. Rule 10(a)(ii) of Part II of KS & SSR is applicable.

Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce community certificate issued from the revenue authority concerned and the Gazette Notification for the same at the time of certificate verification.

Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. "Candidates who have Aadhar Card should add Aadhar card as I.D Proof in their profile".
