## **NOTIFICATION**

The following is the Ranked list of candidates for selection to the post of **BEAT FOREST OFFICER (NCA-SCCC)** on Rs.20,000-45,800/- in **Forest Department** in **Palakkad** District notified in the Gazette dated 29.12.2017 (Cat.No.640/17) found suitable by the Commission and arranged in the order of merit based on the OMR Test, Endurance Test, Physical Efficiency Test and the verification of original documents of candidates included in the Short list published on 08.02.2019. This Ranked List is brought into force with effect from **17.03.2020**.

The Ranked List thus published will be valid until candidates are advised and appointed against vacancies that arise due to the paucity of SCCC candidates during the currency of Ranked list published on 31.01.2017 for the above post or three years from the date of publication of this NCA Ranked list whichever is earlier. Candidates from this list will be advised for appointment in accordance with the Rules and Orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission during the pendency of the list. As the advice for appointment depends on the occurrence of vacancies, there is no guarantee that all candidates included in the list will secure appointment. The candidates remaining in the list at the time of cancellation will have no claim at all for appointment on the basis of the inclusion of their names in the list.

Candidates who wish to obtain a photocopy of their OMR answer sheet (Part A & Part B) relating to this selection shall remit a fee of Rs.335/- (Three hundred and thirty five rupees only) by way of chalan in any of the Treasuries in the State under the Head of account: 0051- PSC-800-State PSC-99 Other receipts. The duly filled in application in the prescribed form (available from the Commission's website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a>) along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission District Office, Palakkad within 45 days from the date on which this Ranked List is uploaded in the official website of the Commission. A copy of an answer sheet will be issued only once to a candidate. Candidates are prohibited from applying for a copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. Applications received after the stipulated time will not be entertained and fee once remitted will not be refunded.

A period of **45** days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the date on which this Ranked List is uploaded in the official website of the Commission. The candidates can avail only one chance.

"Applications for rechecking of answer scripts should be submitted in the prescribed form available free of cost from the Enquiry Sections of the various offices of the Commission or its photocopy, or downloaded and printed in the A4 size paper from the Commission's Website <a href="https://www.keralapsc.gov.in">www.keralapsc.gov.in</a> or photocopied there from. Applications submitted in any other manner will not be considered".

The application for rechecking, along with original chalan receipt for the prescribed fee of Rs.85/- (Eighty five rupees only) under the head of account "0051-PSC 105 State PSC 99-Examination Fee", addressed to the District Officer, Kerala Public Service Commission District Office, Palakkad should reach the office on time. Application for rechecking received after the stipulated time will not be entertained and fee once remitted will not be refunded.

"Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with Signature, Name, Designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalisation of Ranked List. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of requisition, based on which he/she is to be advised."

The A Part and B Part of OMR Scripts will be destroyed after completing six months period from the date of finalization of Ranked List ie, on 17.09.2020.
