4. Number of vacancies : 01 (One) (NCA-ST)

The above vacancy is now in existence. The Ranked list published as per this notification will be valid until candidates are advised and appointed against the vacancies earmarked for the above community but remains unfilled due to the paucity of candidates during the currency of the Ranked list published on 16.07.2012 for the post. This is the Fourth NCA Notification for the post owing to non availability of qualified candidates belonging to the above community as per the First NCA Notification (Gazette Date 29.12.2015 Category No.593/2015), Second NCA Notification (Gazette Date 29.12.2017 Category No.614/2017), Third NCA Notification (Gazette Date 29.12.2018 Category No.339/2018).

candidates will be considered).

Note:1:- Applications submitted by candidates belonging to communities other than

the above will be summarily rejected. Individual communication regarding

the rejection of their application will not be issued.

Note:2:- Women Candidates are not eligible to apply.

6. Age limit : 18-50. Only candidates born between 02.01.1970

and 01.01.2002 (both dates included) are eligible to

apply for this post.

KS&SSR Rule 10 (c) regarding relaxation of upper

age limit is not applicable.

8. 8th Standard Pass or Army Second Class or its equivalent qualification

9. Physical Fitness:

Height: 160cm

Chest (Normal): 75cm Chest (on expansion): 80 cm

Note:1:- KS&SSR Part-II Rule 10 (a) (ii) is applicable.

Note:2:- Candidates who claim equivalent qualifications instead of qualification mentioned in the Notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.

<u>Note:3:-</u> In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Community Certificate at the time of certificate verification.

8 Mode of Submitting applications:

- (A) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for the post. The photograph uploaded in the profile should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application from their one time registration profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application, candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is received as provisional and the details cannot be deleted or altered after submission. The application submitted not in accordance with the conditions stipulated in the notification will be summarily rejected in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for.
- (B) If written/ OMR/ Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the

Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- (C) Appropriate disciplinary action as per Rules of Procedure Rule 22 shall be initiated against those candidates who submit applications with bogus claims of qualification regarding education, experience etc. and submit confirmation for writing the examination, irrespective of whether they are present or absent for the examination.
