- **Note:-** The above Vacancy is now in existence. Candidates shall also be advised from this list against vacancies exclusively reported for Scheduled Tribes and only in the absence of Scheduled Tribe candidates in this list, fresh notification for Scheduled Tribes will be issued for vacancies reserved exclusively for them.

5 Method of Appointment : Direct Recruitment (Special Recruitment from Scheduled Castes/Scheduled Tribes).

7 Qualifications

1. Graduation in Science with Physics as one of the subjects conferred /recognized by any of the Universities in Kerala

OR

B.Tech. Awarded/recognized by any of the Universities in Kerala

OR

Diploma in Engineering after undergoing a regular course of study of three years with three years professional experience in Central or State Government or in Public Sector Undertaking or Registered Private Sector Undertaking after acquiring the basic qualification prescribed for the post, in the field of Engineering in which the candidate has earned the Diploma

- 2. Must be able to speak, read and write Malayalam
- **Note:-** If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce Community Certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

<u>Probation</u>: Every person appointed to the category shall, from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

Training: Every person appointed to the category shall have to complete the Basic Training Course as specified in the Legal Metrology Act 2009 (Central Act 1 of 2010) or any rule made thereunder, if he had not undergone that training previously.

iii. A test on the Legal Metrology Act, 2009 and Rules, within the period of probation, if not passed previously.

No application fee is required. Candidates shall view and have a printout of the application by clicking the link Registration Card in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after the last date of receipt of application. The application will be summarily rejected if noncompliance with the notification is found in due course of processing.
