Applications are invited from qualified Scheduled Caste / Scheduled Tribes candidates of Kerala State for selection to the following post. Applications must be submitted online through the official website of the Commission after One Time Registration. Candidates who have already registered can apply through their profile. The photo uploaded through One Time Registration should be the one taken after 31.12.2010 and also bear the name of candidate and the date of photo taken should be recorded in the bottom of the photograph. The uploaded photo will be having a validity of ten years from the date of photograph taken.

1 Name Of Department : Kerala Higher Secondary Education

2 Name of post : Higher Secondary School Teacher (Jr.)

Statistics (Special Recruitment for SC/ST)

3 Scale of pay : ₹ 32300-68700/-

**4 No. of Vacancy** : 02 (Two)

Note:- The above Vacancies are now in existence. The Ranked list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for special recruitment for SC/ST only during pendency of the list. Candidates against vacancies exclusively reported for Scheduled Tribe will also be advised from this list and only in the absence of Scheduled Tribe candidates in this list that fresh notification for Scheduled Tribes for vacancies reserved exclusively for them will be issued.

5 Method of : Direct Recruitment (Special Recruitment from Appointment Scheduled Caste /Scheduled Tribes)

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

**6 Age** : 20-45

Only Candidates born between 01.01.1975 and 02.01.2000 (both dates included) are eligible to apply for this post. No other age

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

# 7. Qualifications

(I)Masters Degree in the concerned subject with not less than 45% marks from any of the Universities in Kerala or a Qualification recognised as equivalent thereto in the respective subject by any University in Kerala.

II

- (1) B.Ed in the concerned subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any University in Kerala.
- (2) In the absence of persons with B.Ed. Degree in the concerned subject, B.Ed. degree acquired in the concerned faculty as specified in the Acts and Statutes of any of the Universities in Kerala.
- (3 In the absence of persons with B.Ed. Degree as specified in items (1) and (2) above, persons with B.Ed. Degree in any subject acquired after a regular course of study from any of the Universities in Kerala or a qualification recognised as equivalent thereto by any of the Universities in Kerala.

#### NOTE:

- (1) In the absence of B.Ed. Degree holders, candidates having Masters degree with not less than 45% marks and who have passed State Eligibility Test will be considered. Preference will be given to those who have acquired Ph.D. Degree or M.Phil degree or qualified at Junior Research Fellowship/National Eligibility Test. The teachers appointed under this provision will have to acquire B.Ed. degree at their own expense within 5 years from the date of entry in service.
- (2)Persons who have acquired M.Ed. in the subject concerned recognised by any University in Kerala are exempted from B.Ed. Qualification.
- **III.** Must have passed the State Eligibility Test for the post of Higher Secondary School Teacher conducted by the Government of Kerala or by the Agency authorized by the State Government.

# **Exemptions**

- 1) Those persons who have passed the State Level Eligibility Test for the post of College Lecturers conducted by Government of Kerala are exempted from passing the State Eligibility Test for Higher Secondary School Teacher.
- 2) Those persons who have passed the National Eligibility Test/Junior Research Fellowship shall be exempted from passing the State Eligibility Test.
- 3)Persons with Ph.D./M.Phil/M.Ed. Degree shall be exempted from passing the State Eligibility Test provided the M.Phil. in the concerned subject should be one

awarded by any of the Universities in Kerala or recognised as equivalent thereto by any of the Universities in Kerala.

4) The teachers who have completed 10 (Ten) years of approved teaching service at the High School level in the General Education Subordinate Service shall be exempted from passing the State Eligibility test for Higher Secondary School Teacher.

**Note:** Higher Secondary School Teacher (Junior) means Part-Time post of Higher Secondary School Teacher.

**Note**: (i)Rule 10(a)(ii) of part II of KS&SSR is applicable

- (ii) Candidates who claims equivalent qualification instead of qualification mentioned in the notification shall produced the relevant Govt. Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- (iii) If the caste of the candidate is wrongly mentioned in their SSLC book , they should claim their original caste in their application and should produce, community certificate issued from concerned revenue authority and the Gazette Notification of the same at the time of certificate verification .

**Probation**:- Every person appointed to the post shall be on probation for a total period of two years on duty within a continuous period of three years.

# 8 Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link to apply for a post. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registeration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. The profile correction made by the candidate or in the office of the Kerala Public Service Commission on request after the last date fixed for receipt of application will not be reflected in the application. Such corrections will be in effect on the date on which corrections have been made. Those who have Aadhar Card should add Aadhar card as ID Proof in their profile

- 12 Appointment are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in GO. (MS) NO. 142/72/PD Dated 13.04.1972, G O. (MS) NO.309/73/PD Dated 29.11.1973, G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O.(P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled caste/ Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
- 13 If written / OMR/ Online Test is conducted as part of this selection, candidates shall submit a conformation for writing the examination through their One Time Registration profile. Such candidates alone can generate and download the Admission Ticket in the last 15 days till the date of test. The applications of candidates who do not submit conformation within the stipulated period, will be rejected absolutely. The period regarding the submission of conformation and the availability of admission tickets will be published in the examination it self. Information in this regard will be given to the candidates in their profiles and in the mobile phone number registered in it.
- **14.** As per Rule 22 of the KPSC Rules of Procedure, 1976 appropriate disciplinary action will be taken against those candidates who submit application for the post with false claims of possession of prescribed qualification, experience etc and give confirmation for examination, irrespective of the fact that they have appeared for the examination or not.
