(i) The selection in pursuance of this notification will be subject to the rules amended as per GO(P) 12/2016/P& ARD dated 04.06.2016

(ii) The above Vacancy is now in existence. The list of selected candidates published by the Commission shall remain in force for a minimum period of one year and a maximum period of three years provided that the said list will not continue to be in force if a new list after the expiry of the minimum period of one year is published. Recruitment will be made for the above vacancy and also for the vacancies reported for Special Recruitment from Scheduled Tribes during the currency of the list.

Note <u>(ii):</u>

The selection in pursuance of this notification will be made on a Revenue District basis subject to the Special conditions laid down in G.O (MS)No.154/71/PD dated 27.05.1971. A candidate advised for appointment in one Revenue District from the Ranked List so prepared is not eligible for transfer to another District unless he/she completes five (5) years continuous service from the date of commencement of service in the former District. Even if, transfer is allowed after five (5) years, it will be subject to the rules in GO(P)No.4/61/PD dated 02/01/1961. Candidates already in Government service, holding the post in one District are restricted from applying for the same post in another District. But they can apply for higher posts when notified.

Note <u>(iii):</u>

Candidates from the Ranked List for districtwise selection will be advised for appointment against the Head quarters vacancies also. As per the provision in G.O(Ms)154/71/PD dated 27.05.1971 appointment against the Headquarters vacancies will be started from Thiruvananthapuram District. Separate option need not be given for this.

5 Method of Appointment : Direct Recruitment

<u>Note:-</u> Applications received from candidates other than Scheduled Tribe will be

rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

6 Age

18 – 41

Only Candidates born between 02/01/1979 and 01/01/2002 (both dates included) are eligible to apply for this post.

Note: In the absence of qualified candidates within the age limit upper age limit shall be relaxed upto 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

7 Qualifications:

Should have passed standard VII and should not have acquired any graduation.

Note:(i) Part II Rule 10(a)ii of KS&SSR regarding qualification is applicable for this selection.

(ii) As per this notification candidates possessing any degree are ineligible for this post. If applications are submitted contrary to the above direction by suppressing the fact and if he/ she is found selected, his/her applications will be summarily rejected, his/her name will be removed from the ranked list and disciplinary action/ punishment including removal from service will be taken against him/her at any stage of selection. However candidates belongs to the Ex-servicemen who have acquired the Indian Army Special Certificate of Education or equivalent certificate from Navy/Air-force shall be eligible to apply for this notification as per GO (P) No. 05/2018/P&ARD dated 19/04/2018.

(iii) Candidates require good physique besides the above general qualification for the following posts and candidates will be advised only after obtaining Medical Certificate (Medical Certificate should be issued by a Medical Officer in Govt. Service not below the rank of Assistant surgeon).

- 1. Matron, Balamandir Kozhikkode
- 2. Watch woman in the welfare institution under social Justice Department.
- 3. Cleaner and Sewer cleaner in the public Works Department.

4. Gate keeper Gr.II and Lascar Gr.II in the printing Department.

(iv) Physically Handicapped persons are not eligible for appointment to the post of Watcher, Watchman, Night Watcher, Marker (Medical College, Collegiate Education & Technical Education Department), Regular Marker (Animal Husbandry Department), Chainman (Land Revenue and Town Planning Department) and Lascar Grade II/Gate Keeper Grade II in Printing Department included in the Kerala Last Grade Service.

(v) Women candidates are not eligible for appointment in the following posts.

- 1. Watchman (All categories), Watcher
- 2. Night Watchman
- 3. Guard/Night Guard
- 4. Chowkidar
- 5. Cleaner cum conductor
- 6. Cleaner (Boat cleaner, Tractor Cleaner, Van cleaner, Lorry cleaner,

Ambulance cleaner)

7. Lascar

8. Gate keeper

9. Bull keeper

10. Animal keeper in Drugs Control Department

(vi) Watch Woman in the Welfare Institution under Social Justice Department will be filled up from the woman candidates only. Any other posts identified for woman candidates will be filled up from the woman candidates after obtaining willingness. (vii) Persons professing Hindu faith alone will be appointed to the posts in the Hindu Religious & Charitable Endowment Departments.

(viii) Vacancies for Last Grade Service in KMCS will also be filled up from the Ranked List prepared in pursuance of this notification without obtaining willingness from the candidates.

(ix) Only one common Ranked List will be prepared for the various posts in the Last Grade Servants of the post applied for as Last Grade Service.

(x) Those candidates who have claimed equivalency for qualifications should produce the Government order proving the same at the time of certificate verification in order to consider as equivalent.

(xi) If the caste of candidates is wrongly mentioned in their SSLC book, they should claim their original caste in their applications and should produce caste certificate issued from concerned revenue authority and the Gazette Notification for the same at the time of certificate verification.

(xii) Candidates who make bogus claims about the requisite educational qualification, experience and provide confirmation irrespective of whether they attend or not attend the examination are liable to disciplinary proceedings as stipulated in Rule 22 of KPSC Rules of Procedure 1976.

8. Mode of Submitting application:

Candidates must register as per 'ONE TIME REGISTRATION' with the official website of Kerala Public Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have already registered can apply by logging on to their profile using their User-ID and password. Candidates must click on the 'Apply Now' button of the respective posts in the Notification Link for applying for a post. The photograph uploaded should be one taken on or after 31/12/2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates can view and have a printout of the details in the profile by clicking the link Registration Card. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of each application, the candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application once submitted is treated as provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, experience, community, age etc. have to be produced as and when called for. "Candidates who have AADHAAR Card should add AADHAAR Card as I.D proof in their profile".

The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calendar itself. Information in this regard will be given to the candidates in their respective profiles and in the mobile phone number registered in it.

- 13 Appointments are made on the basis of the rank secured in the ranked list of candidates prepared in pursuance of this notification subject to the conditions laid down in G.O.(P) No. 21/76/PD dated, 17.01.1976 and G.O. (P) No.25/94/GAD dated, 22.01.1994 allowing special reservations to Scheduled Tribes in accordance with the procedures made for this purpose from time to time and subject to the rules under sections 3(c), 17(a), 17(b) of Part II of Kerala State and Subordinate Service Rules, 1958.
