7. Qualifications

- 2. Must possess Typewriting English Higher (KGTE/MGTE) or its equivalent and Computer Word Processing or its equivalent.
- 3. Must possess Typewriting Malayalam Lower (KGTE) or its equivalent.
- 4. Computer Data Entry Course Certificate issued by a Govt. recognised Institution for appointment.
