NOTIFICATION

The following is the list of candidates found suitable by the Commission on the basis of candidates carried over from the Ranked List brought into force with effect from 31/08/2016 and the Objective Type (OMR) Test held on **06.07.2019** for selection to the post of **Lower Division Typist** (**Part II By Transfer**) on **₹ 19,000-43,600/- in Various Departments** in Ernakulam District and arranged in the order of merit. The Ranked List is brought into force with effect from **10.11.2020**.

The ranked list shall remain in force for a minimum period of one year, subject to the condition that the said list will continue to be in force till the publication of a new list after the expiry of the minimum period of one year or till the expiry of 3 years whichever is earlier. Candidates from this list will be advised for appointment in accordance with the rules and orders regarding reservation and rotation as amended from time to time, if applicable, against vacancies reported to the Commission. In case the candidates included the Ranked list couldnot secure appointment before the expiry of Ranked List, the names of such candidates will be included at the top of the new Ranked List of the Low paid Employees drawn up by the Commission subsequently in the same order and they will be advised for appointment accordingly.

Since a common objective type (OMR Valuation) test was held for this post, the marks awarded to the candidates included in the Ranked List and marks of OMR Test relating to all candidates appeared for the test will be published only after the publication of the Ranked List (including NCA Notifications) which will be finalised on the basis of the Common Test.

According to the existing procedure, revaluation of Answer Script is not allowed. But Answer Scripts will be rechecked if the candidates apply for in the prescribed application form available free of cost from the Enquiry Sections of the various Offices of the Commission or its photocopy, or downloaded and printed in A 4 size paper from the Commission's website www.keralapsc.gov.in or Photocopied there from along with prescribed fee of Rs. 85/- (Rupees Eighty Five Only) under the Head of Account 0051 - PSC - 105 State PSC 99 - Examination Fee addressed to the District Officer, Kerala Public Service Commission District Office, Ernakulam-682016. Applications submitted in any other manner will not be considered. A period of 45 (Forty Five) days time to apply for rechecking of Answer Scripts will be allowed to candidates with effect from the Date of uploading of the Ranked List in website. The last date for receipt of applications is 25/01/2021.Candidates can avail only one chance after the Approval of Ranked List. Rechecking of invalidated answer scripts due to any defects will not be

considered. Application for Rechecking received after the stipulated time will not be entertained and Fee once remitted will not be refunded.

Candidates who wish to obtain a photocopy of their OMR Answer Sheets (Part A & Part B) relating to this selection shall remit a Fee of Rs. 335/- (Rupees Three Hundred and Thirty Five only) in any of the Treasuries in the State (Head of Account: 0051 - PSC - 800 - State PSC -99-Other Receipts). The duly filled in application in the prescribed form available from the Commission's website www.keralapsc.gov.in along with the original chalan should be submitted to the District Officer, Kerala Public Service Commission District Office, Ernakulam-682016 within 45 (Forty Five) days from the date of uploading of the Ranked List in website. A copy of the answer sheet will be issued only once to a candidate. Copies of OMR answer sheets invalidated due to any defect will not be issued. Candidates are prohibited from applying for copy of an answer sheet which is not their own, and legal proceedings will be initiated against those who do so. The last date for receipt of applications is 25/01/2021. Applications received after the prescribed date will not be entertained.

The result of rechecking of OMR scripts will be intimated in due course. But photo copy of the OMR and answer scripts will be issued only after the publication of all the Ranked Lists to be finalised on the basis of the common test for each posts.

Any candidate can relinquish his/her right for appointment in writing duly attested by a Gazetted Officer of State/Central Government with signature, name, designation and Office Seal along with a notarized affidavit and a self attested copy of an ID proof bearing photograph as enlisted in the General Conditions. The request for relinquishment received within 15 days from the date of publication of Ranked List in the official website of the Commission will be honoured against the requisitions of vacancies that are pending with the Commission upto the finalization of ranked list. After the publication of the Ranked List, the request for relinquishment will be considered only if such request is received on or before the date of receipt of requisition, based on which he/she is to be advised.

The A part and B part of OMR scripts will be destroyed after completing 6 months period from the date of finalisation of Ranked list included in the common test held on 06/07/2019.
