5. Method of appointment : Direct Recruitment. (Candidates belonging to the Ezhava/ Billava/ Thiyya community only.)

Note:- Applications submitted by candidates belonging to the Communities other than the above will be summarily rejected. Individual communication regarding the rejection of their application will not be issued.

6. Age limit : 18-39. Only candidates born between 02.01.1981 and 01.01.2002 (both dates are included) are eligible to apply for this post. (Including the relaxation as per para

2(i) of the General Conditions)

Note:- For concessions allowed in upper age limit, subject to the condition that the maximum age limit shall in no case exceed 50 years, please see para (2) of the General Conditions under part2, except para2(i) of the Notification.

7. Qualifications : (1) First Class Bachelor's Degree in Commerce from any

University after undergoing regular recognised

institutional course of study.

(2) Diploma in Commercial Practice awarded / recognised by Government of Kerala after three years of regular institutional course of study.

Note :- 1. Rule 10 a (ii) of part II of KS&SSR is applicable.

- 2. Candidates who claim equivalent qualification instead of qualification mentioned in the notification shall produce the relevant Government Order to prove the equivalency at the time of verification, then only such qualification shall be treated as equivalent to the prescribed qualification concerned.
- 3. In the case of difference in original caste/ community claimed in the application and that entered in SSLC book, the candidate shall produce a Gazette notification in this regard, along with Non Creamy Layer Certificate/ Community Certificate at the time of certificate verification.

8. Method of submitting applications:

- (a) Candidates must register as per 'ONE TIME REGISTRATION' with the Official Website of Kerala **Public** Service Commission www.keralapsc.gov.in before applying for the post. Candidates who have registered can apply by log in on to their profile using their User-ID and password. The photograph once uploaded meeting all requirements shall be valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application on the profile candidates must ensure correctness of the information in their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if non-compliance with the notification is found in due course of processing. - (b) If Written/OMR/Online Test is conducted as part of this selection, candidates shall submit a confirmation for writing the examination through

their One Time Registration profile. Such candidates alone can generate and download the Admission Tickets in the last 15 days till the date of Test. The applications of candidates who do not submit confirmation within the stipulated period, will be rejected absolutely. The periods regarding the submission of confirmation and the availability of Admission Tickets will be published in the Examination Calender itself.
